## Marker's Report Zone Theory May 2015



53 of 77 Umpires were successful in this exam (69%).

Congratulations to Denise Sheehan (Wellington) and Belinda Knapp (Eastern Southland) who both scored 100%! A fantastic effort – Well Done! Special mention also to Raewyn Neale (Kerikeri) and Roger Rota (Waitakere) who scored 49.5.

It was disappointing to see the number of Umpires who lost marks in Questions 10 - 17 where the correct answer was already provided. The intention of these questions is to clearly test an Umpires' rule knowledge without focussing on the wording required in the answer. It is difficult to obtain a pass with errors in these questions.

## Areas for future reference:

Question 4:	Umpires need to be able to identify the hand signals as set out in the Appendix of the Rule Book. There is no hand signal illustrated for replay ball.
Question 5d:	Poorly answered.
Question 6b:	Umpires take a Toss Up in their own goal circle.
Question 10:	Questions a, c, e and f were poorly answered.
Questions 12 - 14:	Poorly answered
Question 15:	Despite this question being asked in every recent exam, Umpires continue to misunderstand this scenario.
Question 21:	A player is entitled to land within 0.9m provided no interference occurs.
Question 22:	A number of Umpires incorrectly stated that the Centre Pass was not correctly received. The question clearly states that the ball lands out of court behind the <u>Centre Third</u> Side Line.
Question 23:	Some umpires confused this question with the Obstruction rule.
Question 24:	The Rule Book does not allow an Umpire to advance a penalty for inappropriate comments from the Team Bench. This is different to a disputing on court player.
Question 26:	The penalty awarded is a Throw In, not a Free Pass.
